Monsievr, defpuis vous auoir efcrit par le Sieur de faint Romain, & vous auoir donné aduis de la mort de la Nouë & du Comte de Montgomery, ie me retiray avec mes troupes à Nantes pour me rafraifchir, fuyuant le mandement que Monfeigneur le Duc de Mercure m'en auoit faict, tant par ses lettres que par le Sieur de Genlis, la Motte, qui me vint trouuer, expres au Chafteau de Nubourg, où i'auois mené le fils du Millord Honfedō, que nous prinfmes prifonnier au dernier récontre. La Royne d'Angleterre à faict grand' infstance enuers le Roy de Nauarre, qu'il euft à employer ses moyens pour mettre le fils dudit Millord en liberté, à quoy Môfeigneur de Mercure ne veut entendre, quelque fupplication que le Roy de Nauarre luy en ait faicte, par ses deputez: finon en rendant Môfeigneur le Duc d'Elbeuf prifonnier à Loches, en pleine & entiere liberté. Ce q̄ ne pouuant faire le Roy de Nauarre, s'excusât qu'il eft entre les mains du Duc d'Efperton qui tient du tout Loches à fa deuotion, Môdit Seigneur n'eft pas refolu de le deliurer qu'à bonnes enfeignes. Le Prince de Dôbes eschappé de la dernière deffaicte, s'eft retiré avec fort peu de gés dâs Rênes, où il feroit biē toft affiegé, n'eftoit les forces que mondit Seigneur de Mercure à enuoyé en l'armee de Monfeigneur le Duc de Mayène, fous la conduite du Sieur de S. Laurens: neantmoins il doit biē toft receuoir quatre mille hômes du Roy Catholique, dont il a efté affeuré par Môfieur le Cômâdeur Morceau, qui faict toute diligêce pour leur acheminemēt. Cependant la Roine d'Angleterre aiât enuoyé douze ou quinze cens Anglois fous la conduite du Millord Hauart en Bretaigne, lors qu'elle fçauoit q̄ môdit Seigneur de Mercure eftoit defnué de forces pour les auoir enuoyees en Lorraine, arriuerent à Vitray, ville distante de Rênes de treize à quatorze lieûes, le 21.iour de Septembre dernier, où ayâts feiourné douze iours pour fe rafraifchir en intētion de fe venir ietter dans Rennes pour defendre la ville, au cas que môdit Sieur de Mercure les vint affieger. Ce qu'eftant denoncé à môdit Sieur, il refolust d'y donner ordre, & pour ceft effect m'efcriut de faire rebrouffer chemin à mes troupes qui eftoyent de fix cés hommes de pied, pour me ioindre au Sieur d'Aradon, qui auoit 300.cheuaux. Ce qu'eftant faict & ayans ioincts môdit Sieur de Mercure pres Chafteau-bourg, nous eufmes aduis, que le ieune la Hunaudaye & le Millord

Hauart, avec leurs troupes, qui pouuoient faire en tout douze cens hōmes de pied, & cinq cens cheuaux eftoyēt partis de Vitray le 4.d'Octobre, iour de S.Frāçois, & venoyent coucher à S.Iean fur Vilaine deux lieuēs pres de Chafteau-bourg, fur le grand chemin de Vitray à Rennes. Mondit Seigneur qui s'eftoit mis entre-deux, avec forces inegalles: car il n'auoit que huict cens hommes de pied, & quatre cens cheuaux, feit affembler fon Cōfeil pour deliberer s'il deuoit combattre ou non. Le Marquis de Chauffein, Prince de grande expectation, remonftroit qu'il valloit mieux combattre que de fe retirer, & qu'il failloit s'affeurer que Dieu leur affifteroit, & qu'il ne permettroit point que les ennemys euffent le deffus, qui ne pouuoient auoir que cinq ou fix cens hommes d'avantage, & que fe retirer, mondit Seigneur ne le pouuoit faire, fans perte de fa reputation. Le sieur d'Aradon au contraire remo nftroit combiē les batailles eftoyent incertaines, & qu'il valoit beaucoup mieux ceder vn peu, que de mettre en hazard vne telle Prouince que la Bretaigne, qui feroit en danger de fe perdre, fi mondit Seigneur demeuroit au combat, pour eftre la perte des Chefs, vn abaiffement de coeur aux Soldatz, effroy & efpouquantemēt des villes, qui apres Dieu, ne s'appuyent que fur eux; & qu'en tout euement fe retirant fans combattre, & l'ennemy entrant dans Rennes, pour leur fecours ils ne pouuoient faire grād cas en Bretaigne pour y auoir peu de retraictes, & que les villes de l'Vnion dudit pays, (eftant bien pouruees de toutes sortes de munitions) il ne falloit rien craindre, Que l'ennemy venoit feulement pour defendre Rennes, fans vouloir rien entreprēdre de nouueau, & partāt qu'à l'occaison d'vne feule ville il ne falloit mettre la Prouince en danger, à quoy le Marquis de Chauffein frere de mondit Seigneur, remonftra la commodité grande, qui pouuoit aduenir au pays, d'empefcher l'entree du fecours ennemy dans la dite ville, & que par ce moyen ceux de la ville, & notamment les pauures Catholiques, fafchez de la domination du Prince de Dombes, & des rauages que noz gens font autour de Rennes, fe pourroient (ennuyez de tant d'incommoditez) ranger à l'Vnion, & que l'ennemy feroit contraint ou de s'en retourner en Angleterre, ou d'aller paffer l'hyuer à Vitray, qu'il falloit (au moins fi l'on pouuoit fans combattre) leur empefcher l'acheminement dans Rennes. Mōdit Seigneur de Mercure apres auoir ouy tous leurs aduis refoluft de fuiure le Confeil de Mōfieur le Marquis de Chauffein, & apres s'eftre recōmandé à Dieu & à noftre Dame, à laquelle tous les Princes de Lorraine ont particuliere deuotion, feit mettre fes gens en equipage pres de Chafteau-bourg, & ayant aduis que l'ennemy s'en approchoit, enuoya vne cōpagnie d'enfans perdu du Capitaine faint Martin les recognoiftre, lequel ayāt rapporté l'eftat de leur armee, mōdit Seigneur refoluft de les attendre, faifant faire alte à fes gens l'efpace de trois heures: en fin mondit Seigneur les ayant faict attaquer par quatre cōpagnies de gens de pied & deux compagnies de Caualerie, noz gēs eurent du pire. L'ennemy pourfuiuant la victoire criāt viue le Roy, fe vint getter à corps perdu au milieu de trois embufcades, que mōdit Seigneur auoit fait demy lieuē pres de Chafteau-bourg, à chafeune defquelles y auoit deux coleuurines, lefquelles commençans à iouēr avec l'infanterie feirent vn tel efchecq & carnage des ennemis, qui s'affeuroyent d'auoir ia la victoire entiere, qu'il en demeura plus de douze cens fur la place, & le refte s'enfuit à vauderoute dans Vitray: ceux qui efchapperent l'efpee du Soldat n'efchapperent point les mains des Payfans, aucuns desfquels y ont faict vn beau butin, le Millord fe fauua en habit defguifé. Nous y auons perdu trois cens bons Soldatz & quelques Gentils-hommes. L'ennemy y a faict perte outre les eftrangers, de plus de cinq cens hommes, & entre autres du ieune d'Auaugour Gentil-homme bien né, mais qui malheureufement fe rangea du party des Heretiques. Le sieur de la Fons, le ieune la Hunauldaye, le Capitaine la Planche, le Sieur de Rofimont, Lieutenāt du Gouuerneur de Vitray, & plufieurs autres Gentils- hommes & Capitaines signalez, y ont laiffé la vie. Nous en auons plus de foixante prifonniers que mondit Seigneur à faict conduire au Chafteau de Nantes. C'eft vn effect fignalé de la bonté de noftre Dieu & de fa prouidence paternelle fur fon Eglife, ayant permis que mondit Seigneur avec vn fi petit nombre de gens, ait deffaict les forces des ennemis, contre l'opinion mefme de fes plus fideles feruiteurs, qui le diffuaderent de combattre. Ayans recenz les forces d'Efpaigne, mondit Seigneur deliberé d'affieger Rennes, Le Prince de Dombes fe trouuant, bien eftōné d'auoir perdu en deux rēcontres & en moins de trois moys, autant de gens qu'il luy en falloit pour executer les entreprifes de fon Roy en Bretaigne. Le tafcheray par voye affeuré de vous faire entendre en ce pays, vous priant me tenir aduerty de ce qui fe paffe en voz quartiers, eft defpuis & attendant de voz nouuelles. Ie prie Dieu.
