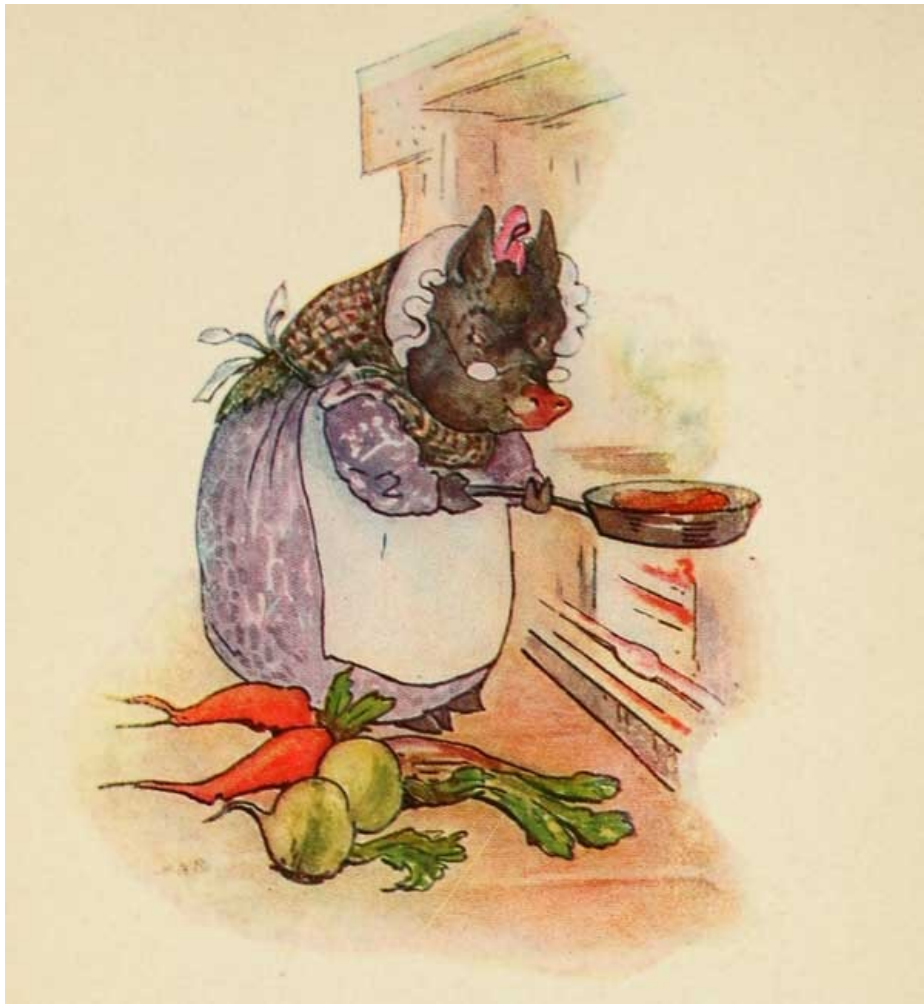


Goosey, goosey, gander,

This pig had a bit of meat;

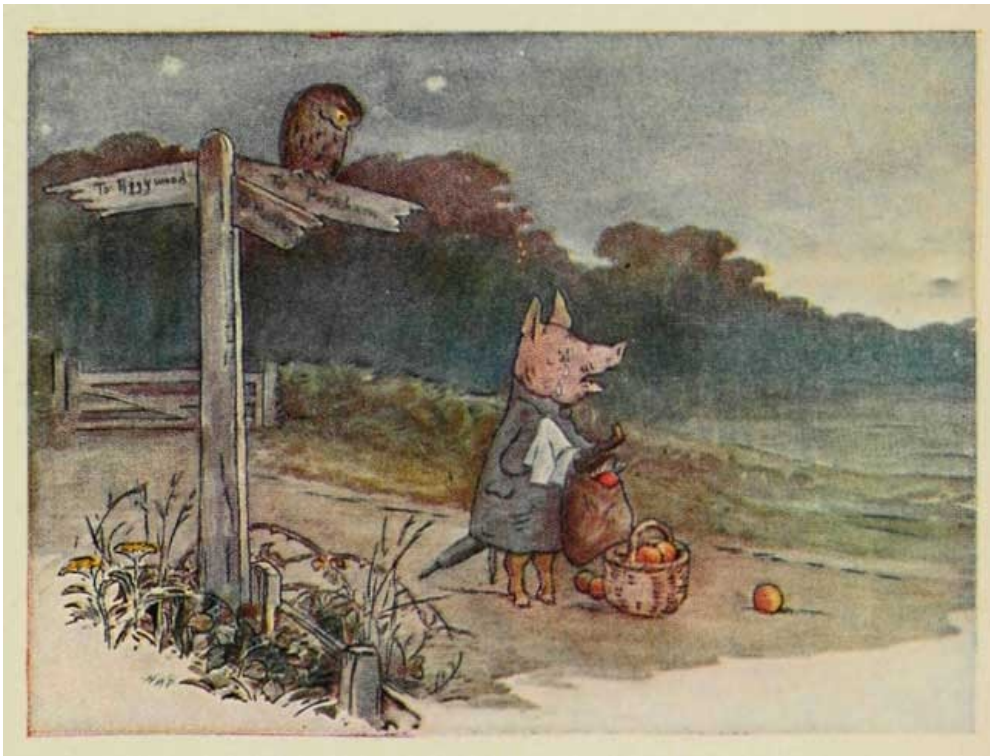

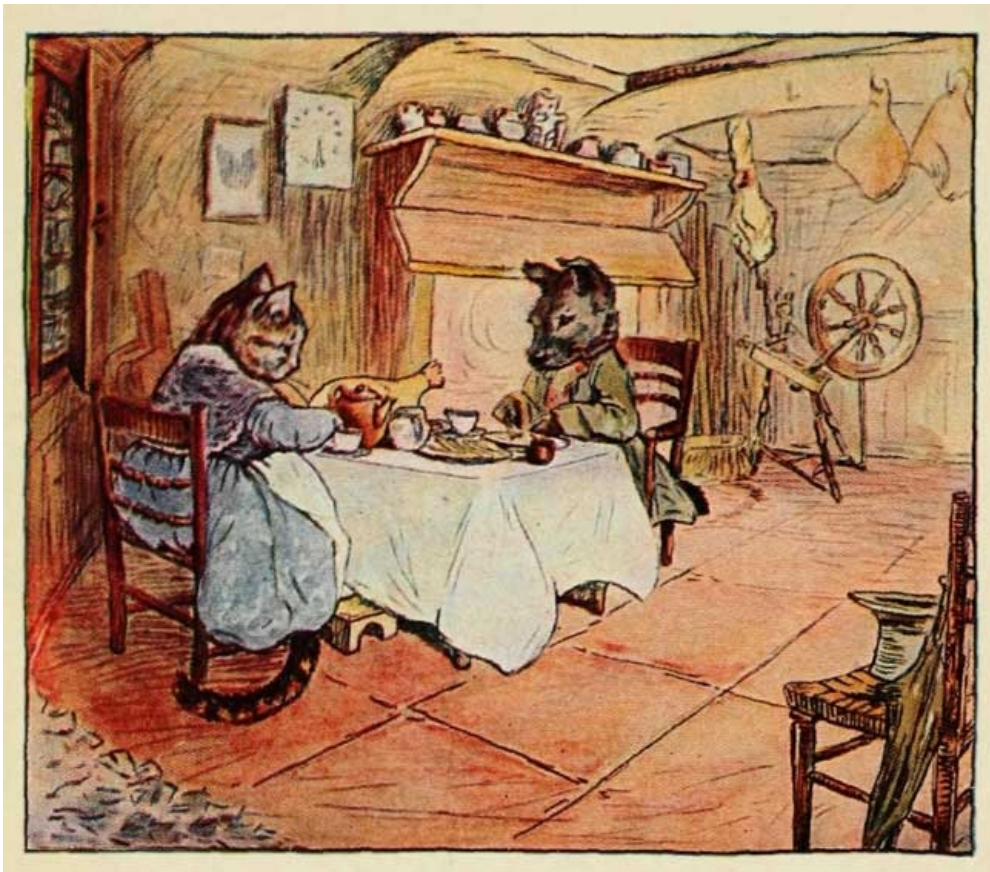


Pussy-cat sits by the fire;

I fare as well as you!"



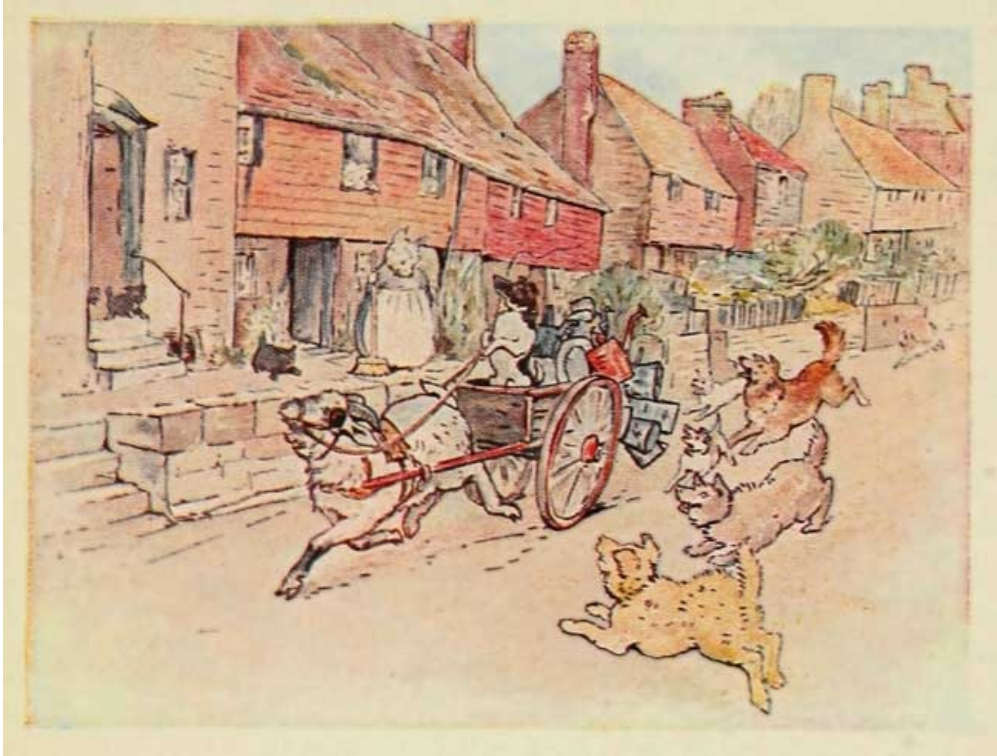


Three blind mice, three blind mice,

The seeds that we have sown.



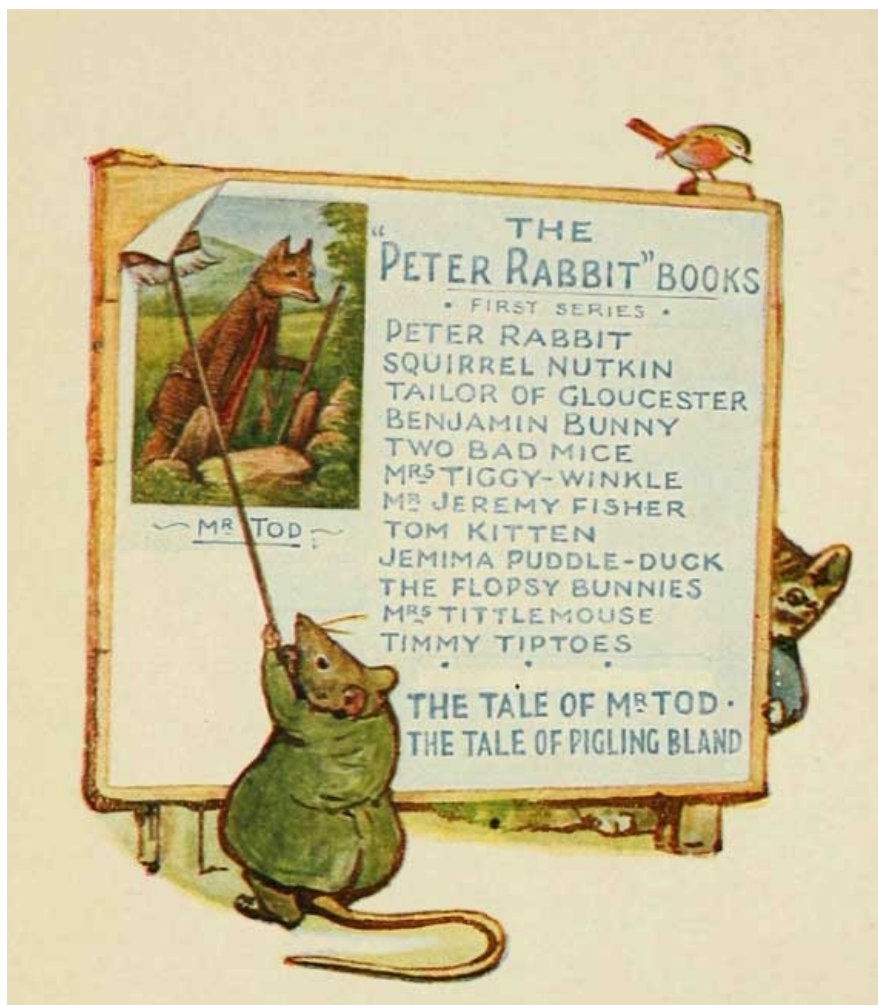
